#### Grandparents raising grandchildren to get Toolbox

Social Development Minister Paula Bennett has announced that a tailored version of the Toolbox parenting programme will be provided free to grandparents raising grandchildren.

"We asked the Parenting Place to provide practical support through the Toolbox programme for people who take in and care for children."

"This is a specific, tailored programme that will help grandparents raising grandchildren with the skills to parent today's children," says Mrs Bennett.

"They do a tough job considering many are caring for children who have been removed from their homes due to abuse or neglect – they need this."

The tailored resource includes nine hours of practical parenting advice on DVD with a manual, which carers can work their way through at home.

Thousands of parents every year get a lot out of attending Toolbox Parenting Groups, but grandparents may prefer an at-home option.

"Some really well-known New Zealanders present the parenting advice on the DVDs including Dame Alison Holst, Bob Kerridge and Pio Terei."

'I am delighted to be able to offer this programme, free of charge, to up to 5,000 grandparents who are raising grandchildren," says Mrs Bennett.

## Dispelling some misinformation about the DVD:

1) The DVD did not cost \$600k to produce. \$25K actually as it was done on a shoestring and not in some flash recording studio, out back of The Parenting Place's back room and to keep the light out from windows black plastic sheets were used. All presenters and professional presenters gave their time free of charge as they all considered this a heart commitment. Obviously there will be more costs in getting DVD onto disc's and postage & printing, but this was just one project for funding, this was not our contract and we are not privy to the rest. But we are thrilled we were part of this project.

2) It does **not** contain your run of the mill parenting tips, which we all know you already have, it is chock full of tips to assist us that are raising children who have experienced less than ideal situations in the past which means extremely hard caregiving for us. **Issues addressed amongst others are attachment disorders, angry children** and positively salutes you as a grandparent in your role. It also has heaps of humour which sees us through those difficult times.

3) You will see some of your fellow GRG members featuring in this where they talk about their experiences and feelings and what it has been like for them, so many of you will relate, as a lot of us are isolated in our role. This DVD will connect you, so you are not feeling so alone and isolated. You will find yourself saying, "yes I feel like that' or "hey I never considered that approach". Trust me when I say you will enjoy and get value from it. For those of you who have attended our GRG conference and raved about them, this is pretty similar, a conference on a DVD which means you can watch it at your own pace and time frame, no traveling and no costs involved.

4) We are aware there has been a bit of knocking about this DVD (on a community page) in regard to parity with Foster care payments, we need to assure you we have not let that go, but we will take anything that is offered to you wonderful people if it makes your lives a little easier. This will also be supplied to all under CYF also.

We are hearing that there appears to be confusion over this, so we thought it would be prudent to clarify this. This package is for children who are under the care & Protection of the Chief Executive under CYF only.



## The Home for Life Support Package

The home for life support package consists of three years support after the transfer of orders to the home for life parents. The package includes:

- reasonable legal costs for the proposed home for life parents
- a \$2,500 upfront payment paid after the home for life orders are granted
- follow up telephone contact with the home for life parents every three months and a support visit every six months
- access to the national foster care training programme
- a baby starter package for children under two years at the time of placement to cover the cost of items such as high chairs, cots, clothing or other things needed to get started with caring for the baby. These items can be provided as soon as the placement is made if required
- linking the home for life parents with the right financial assistance through Work and Income
- identifying needs that could be met by other agencies, and advocating and liaising with the agencies for services, as required

- working with the child or young person's birth family to support on-going contact so that it is safe and works well for the child or young person
- five days of respite care/holiday programme per year for three years if required. This is available for the child or young person in the home for life placement and can include other children in the home. If the parents also want to go to the camp with the children this is an option
- a review prior to the end of the three years to ensure any on-going support needs are identified and referrals to community agencies are made.

## Payment of legal costs when seeking orders

Child, Youth and Family will pay the agreed reasonable legal fees for caregivers who are seeking orders to reinforce and support the home for life placement. This includes:

1. Proposed home for life parents applying for orders in their favour

Payments are made at legal aid rates for the experience level of the solicitor providing the services, using the legal aid level of experience. If the lawyer is an approved counsel for the child then Child, Youth and Family will pay the level two Lawyer for the Child rate for work provided by that lawyer (i.e. not for juniors of that firm).

Child, Youth and Family will pay reasonable costs (usually no more than 10 hours) for filing of applications to obtaining orders in a non contested case. If a case is complex and requires more funding or ongoing work you should obtain an estimate from the lawyer and seek the site managers' approval for additional funding. A prompt response to such requests from the site manager will ensure that the legal process is not unnecessarily delayed.

2. Home for life parents defending any subsequent proceedings bought by birth parents or seeking additional orders, in order to secure the child's home for life placement.

Funding is provided at the discretion of the site manager and approval should be sought first. Child, Youth and Family will not support applications that it does not feel are in the best interests of the child and are not being advanced in a constructive, child focused manner.

## What does the payment of \$2,500 cover and when is this paid?

The \$2,500 is a payment for all home for life parents to provide for the individual needs of the child or young person. The payment recognises that there may be increased costs of an additional child in the home but is not calculated to reflect or replace any sum of money that would otherwise have been paid.

## Who will provide the home for life support?

Generally our NGO providers will provide the home for life support after the orders have been transferred to the home for life parents. The referral form for Home for Life support is available on CYRAS.

In some circumstances, it might be more appropriate for Child Youth and Family to provide the support, for example, in the exceptional circumstances when a Services Order might have been granted.

Some home for life parents may decide they do not want any support when home for life has been achieved. If this is the case, they can be given the contact details of the home for life support agency in the event that they wish to make contact with them at a later date.

## **Financial support through Work and Income**

Home for life parents are eligible to receive the Unsupported Child's Benefit (UCB) which is administered through Work and Income. The rate of the UCB is the same as the foster care allowance. Other supplementary assistance may also be available such as the Child Disability Allowance and a Child Care Subsidy.

Social workers will need to ensure that the home for life parents have met with a Work and Income case manager to clarify their entitlements and have made an application prior to the discharge of orders against the Chief Executive.

The process of determining eligibility and application for the UCB may be unfamiliar to home for life parents, and they will likely appreciate the support of their caregiver social worker or the child's social worker at this appointment. Work and Income will require the following information:

- the child or young person's birth certificate
- the home for life parents passport or birth certificate, their IRD number and a full bank statement
- a copy of the parenting or guardianship order, or a letter from Child, Youth and Family confirming which orders have been made
- details of any income the child or young person receives.

The home for life parent will be expected to make an application for child support against the birth parent/s of the child or young person. If the home for life parents are family members, this expectation could be discussed at a whānau hui. Ensure this has been discussed with the birth parents early in the process and that home for life parents are aware of how to keep their personal details confidential if this is required.

#### Additional support available for home for life

Child, Youth and Family will not continue to pay board payments, clothing allowances or other regular payments and does not expect home for life parents to seek those payments by way of services orders. The Unsupported Child's Benefit paid through Work and Income is intended to cover the general needs of caring for a child.

If additional financial support or specific services are required to meet the specific ongoing needs of a child or young person these will be discussed and agreed prior to the home for life parents seeking orders.

In some instances it may be appropriate for Child, Youth and Family to provide support to home for life parents through a Services Order. Talk with your supervisor or practice leader about the best option based on the needs of the child or young person.

Despite people's best efforts, not every future contingency can be planned for. Therefore, ad hoc financial support can be provided to home for life parents through s389 of the CYPF Act.

#### Where services orders are already in place

Services orders that are already in place will continue and we have an obligation to see these through for the length of the order. At the review time you can discuss the new home for life package. Some caregivers may wish to consider replacing the services order with the home for life support package and this can be negotiated with them.
