

The Māpihi Pounamu Financial Support Scheme accepts applications throughout the year. The closing date for applications is the last day of each term, and the selection panel meets during the following school holidays.

Māpihi Pounamu is a capped fund and assistance can only be allocated to those students who are considered most at risk. Please consider this when making an application.

#### **Aim**

To help ensure that at-risk secondary students participate and achieve in education. It is available to students of all ethnic groups, and targeted at those students who are required to board away from home because they face barriers to learning, either through difficult home circumstances such as ongoing risk to their wellbeing, or lack of supportive care.

#### **Entitlement**

The maximum entitlement per applicant is \$7,500 per year, depending on how much the hostel charges. Where the applicant is also receiving a Government Boarding Bursary, this is deducted from the grant. The funding can only be used for hostel boarding fees at a state or a state-integrated secondary school.

A list of secondary schools with boarding hostels on web site. Schools are listed from north to south. Assistance begins from the term in which the application is approved. Any additional costs need to be met by the parent or caregiver.

#### Scheme Guidelines: Aim of Māpihi Pounamu:

This scheme supports students to attend boarding school so that they may participate and achieve in education. It is targeted at those students who face barriers to learning, either through difficult home circumstances such as ongoing risk to their wellbeing, or lack of adequate supportive care.

#### **BACKGROUND INFORMATION**

### Who may apply for Māpihi Pounamu support?

The scheme is open to secondary students of all ethnic groups who

- face barriers to learning through difficult home circumstances, which require the student to attend a boarding school
- have been accepted for enrolment into a nominated state or state integrated boarding school.

### How do you apply for Māpihi Pounamu support?

Complete the application form. You will need to include a referee's report and confirmation from the Principal of your nominated school that accepting your enrolment will not exceed the number of Māpihi Pounamu students agreed between the school and the Ministry of Education.

If you are applying for Māpihi Pounamu support to attend a state integrated school, you will also need confirmation from the school's Proprietor that accepting your enrolment will not exceed the overall maximum roll, or non preference maximum roll, specified in its Integration Agreement.

#### How are applicants selected?

Application forms (and the letter of referral), are sent to the Ministry of Education. A panel, made up of representatives from the Ministry of Education, Child Youth and Family (CYF), the NZ Police, considers the applications on a regular basis. Applicants are advised of the outcome by letter. The fund is limited, and not all applications will be successful. Applications which are declined can be reconsidered if there is further information available to support the case.

#### What does Māpihi Pounamu provide?

Māpihi Pounamu will pay up to \$7,500 a year towards the boarding school fees of successful applicants. This is paid directly to schools. If students are

also receiving a Boarding Bursary, the combined total will be a maximum of \$7,500 a year.

#### **Ongoing support**

Funding will be provided for a student throughout their schooling, for as long as they remain eligible. Support may be reduced or cancelled if

- the circumstances change
- the student fails to attend school regularly, or
- the student is stood down or suspended.

# Confidentiality

All applications are treated with confidentiality. Information will not be disclosed to a school (unless the parent/caregiver requests this to happen).

#### Restrictions

- Students with CYF status under sections 78, 101, 102, 110, or 140 of the Children, Young Persons and their Families Act 1989 are not eligible for Māpihi Pounamu support (as their boarding fees would normally be met by CYF)
- If applications exceed the funding available, financial support will be allocated to those students the panel determines will be most likely to gain the greatest benefit from participation in the scheme.

A GRG member emails: Both our Granddaughters Boarded at St Kevin's College with the assistance of the Mapihi Pounama Grants, and I'll always maintain that it was because of their Boarding school experience that Kayla is now in her final year for her Masters at Victoria Uni and that Bonnie has passed her second year at Otago Polytech with 100% marks.

So my advice is to go for it, bit daunting to have to fill in all those personal details but what the heck it sets your Grandchild up for life.

### **Hello Fellow Grandparents:**

I would just like to share with other members a very wonderful course that I have just completed and found immensely helpful in the hard world of parenting again in your older years, after a long break of going through those teaching /coping years of pre-schoolers. Yes, I did PPP courses etc. when my own children were young, but this particular course is by far the best I have ever encountered and I thoroughly recommend it.

The 14 week (1 morning per week) is with the Incredible Years Parenting course, run in conjunction with Ministry of education and Barnados.

It is fully funded and has helped me so much in parenting a child who came to me with significant problems and difficulties in emotional control and social skills. It has also helped \*me\* to change my attitude and style of learning to help raise a wee man into a child who will in time become a caring, confident and emotionally balanced young man.

In the ECBI (Eyberg Child Behaviour Inventory) at the beginning of the course, my grandson (aged 3 and half) was scored with an intensity of 68, Problem 58 (a score of 60 or more indicates behaviours with significant concern.)

After the 14 weeks, which included lots of practice hands-on homework, teaching and working though the "children's needs" parenting pyramid, ie praise, coaching, encouragement, self-esteem, social skills etc. he was re-rated at Intensity of 54 and Problem 41.

Also the Social Competence Scale before the course came out at 9, which showed significant difficulties with emotional control and social skills. Post course he was rated at 27 which was in the normal range, (17 -27 being in borderline range). This is an immense achievement for both of us, with his social competence score showing a significant increase from 9 to 27.

So if you need to re-learn, have wonderful support, and share with other parents/caregivers going through the same parenting problems, take up the challenge of 3 hours per week and go for it. Contact your local Ministry of Education or Barnados 0800 227 627 to see if there is a course coming up in your own area. *Granny S* 

# Tricia Corin Field Officer: GRG Trust

The previous month I took a case to the Social Security Appeals Authority. This case was for a Grandmother who was declined the Unsupported Child's Benefit. She had taken the case to a Review of Decision via (MSD) Work & Income Benefit Review Hearing and lost this so her next option is to take it to the Social Security Appeals Authority.

I represented this Grandmother (from Whangarei) and it was held in the Auckland District Court. We won the case and the Grandmother received \$11,000 back pay. This decision will have significance to GRG with the reference to the term "Family".

#### Quote

"We must first consider what is meant by the term "Family" in S29.

Ref in S 29 of the Social Security Act 1964 to the parents of the child, whether they be the natural parents, adoptive parents or step-parents suggests that in the first instance what is meant by "family" means **immediate family**, namely a child's mother and father. The reference to "natural", "adoptive", and "Step-parents" suggests that these are the people with a natural responsibility for a child and automatically responsible for the child's care and financial support.

While grandparents or a brother or a sister might also be regarded as part of the child's extended family, the fact that the inability of extended family members to care for a child is not specified as a condition for Unsupported Child's Benefit to be paid suggests that a breakdown in the wider family is not required by s 29(b). Moreover grandparents, uncles, aunts, brothers, and sisters have no legal duty to financially support a grandchild, niece, nephew or sibling. We are satisfied that the term "family" in s 29(b) refers to immediate family rather than extended family".

I have **four** other cases presently with the **Review of Decision** process.

It is very clear that in a great deal of cases where the grandparents are seeking the UCB for their grandchildren, the process is extremely difficult and long and drawn out - some taking over a year to get granted.

The inconsistencies around the country disturb me, as you can have one office of Work & Income who will bend over backwards to help a grandparent and others that will do anything to discourage them away from applying for the UCB, by saying they don't qualify and offer them Family Tax Credits instead.

This does concern me and I am not sure if the Minister Paula Bennett is aware of this. She is quick to say that Grandparents Raising Grandchildren can get the UCB, but a great deal of the time this is not the case.


